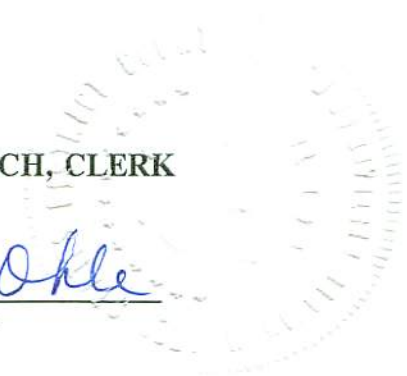
- Jury Verdict.** This action came before the court for trial by jury. The issues have been tried and the jury has rendered its verdict.
